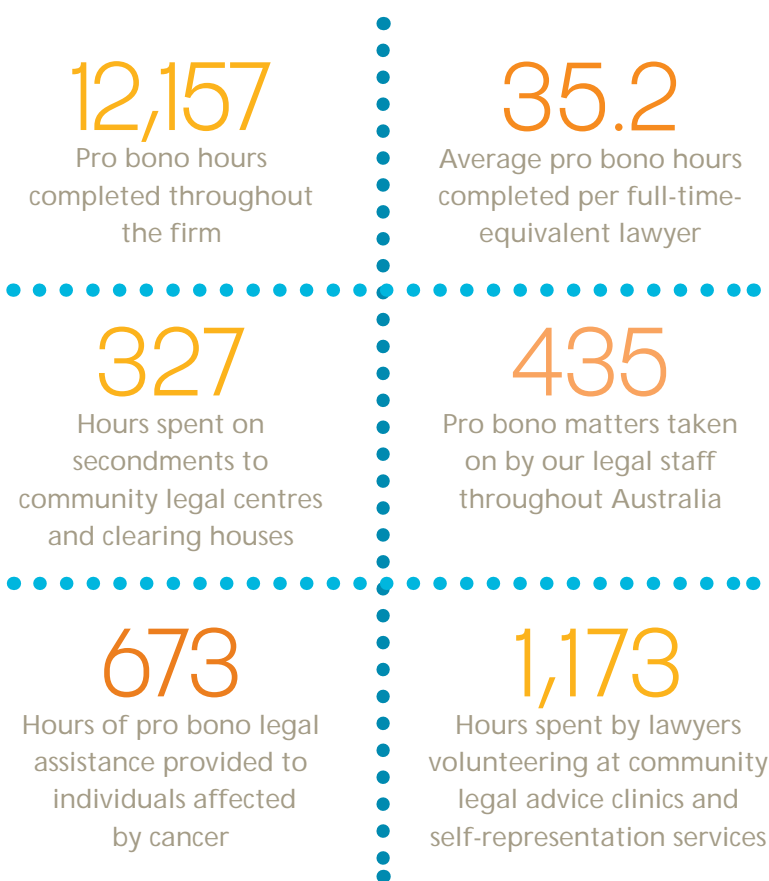
## Sparke Helmore's social sustainability report FY2017/18

# Highlights from the past year

Key activities from our Pro Bono practice and Community program

## Aboriginal Wills Clinics

Aboriginal people have a very low rate of will making, resulting in a high number of burial disputes. To help address this, we hold free community wills clinics, in partnership with local community centres. Our volunteer lawyers have prepared 240 estate documents for 107 clients throughout Australia over the past year.

## Thriving Communities Partnership

We are proud to be a founding partner of the Thriving Communities Partnership, whose aim is to ensure access for all to essential services, including utilities, financial services, telecommunications and transport. We have provided free legal assistance to help them achieve charitable status, as well as develop sponsorship and member agreements.

## NCARA Partnership

Further strengthening our commitment to Indigenous communities, we have pledged to provide free legal work to the Three Rivers Regional Assembly, part of a collaboration of eight Aboriginal Alliances advocating for local decision-making about services delivered to Indigenous communities.

## Cisarua Learning

Cisarua Learning provides a centre for refugee children who are stranded indefinitely in Indonesia. As well as keeping them occupied, it gives them hope through the provision of education and valuable English-language skills. We recently provided them with free legal assistance to establish themselves as a charity.

## The Forgotten Victims

A large number of women who are released from prison go on to experience intimate partner violence. In partnership with Australia's National Research Organisation for Women's Safety, we partly funded a new research project to identify areas of unmet need and current barriers for these women, with an aim of exploring potential solutions. ## Usman Khawaja Foundation

Sparke Helmore has provided free legal assistance to establish the Usman Khawaja Foundation, an important initiative that provides educational and sporting opportunities to disadvantaged youth, predominantly refugees and new migrants.
